

## **Gift Card Giveaway**

### **Official Rules**

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility:** Gift Card Giveaway (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of O'Reilly Automotive Stores, Inc., HelloWorld, Inc., and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. The Promotion consists of a sweepstakes (the "Sweepstakes") and an instant win game (the "Instant Win Game").

**2. Sponsor:** O'Reilly Automotive Stores, Inc., 233 South Patterson Avenue, Springfield, MO 65802. **Administrator:** HelloWorld, Inc., 3000 Town Center, Suite 2100, Southfield, MI 48075.

**3. Timing:** The Promotion begins on December 27, 2017 at 12:00 a.m. Pacific Time ("PT"), ends on January 30, 2018 at 11:59 p.m. PT (the "Promotion Period") and consists of thirty-five (35) daily entry periods (each a "Daily Entry Period"). Each Daily Entry Period begins at 12:00 a.m. PT and ends at 11:59 p.m. PT. Administrator's computer is the official time-keeping device for this Promotion.

**4. How to Enter:** During the Promotion Period, there are two (2) ways to obtain a code ("Code") to enter the Promotion, as outlined below:

- a. Visit O'Reilly Auto Parts:** Go to your local O'Reilly Auto Parts store and obtain a game card. The game card will contain a Code. Then, visit [OReillySweeps.com](http://OReillySweeps.com) and follow the links and instructions to complete and submit the registration form including a valid email address, phone number and Code. You automatically will receive one (1) Sweepstakes entry into the applicable Daily Entry Period drawing and advance to the Instant Win Game page and receive one (1) Instant Win Game play for that day. Once on the Instant Win Game page, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game.
- b. Free Code:** To enter without visiting an O'Reilly Auto Parts store, visit [OReillySweeps.com](http://OReillySweeps.com) and follow the links and instructions to request a free Code. A Code will be sent to the email address provided on the [code request form](#). Then, during the Promotion Period, click on the link found within the email and follow the links and instructions to complete and submit the registration form including a valid email address and Code. You automatically will receive one (1) Sweepstakes entry into the applicable Daily Entry Period drawing and advance to the Instant Win Game page and receive one (1) Instant Win Game play for that day. Once on the Instant Win Game page, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is solely responsible for the functionality of the Instant Win Game.

**Limit:** Each entrant may enter two (2) Codes per day to receive a total of two (2) Sweepstakes entries into the applicable Daily Entry Period drawing and two (2) Instant Win Game plays per day during the Promotion Period regardless of method or combination of method of entry. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of plays/entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's plays/entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the entrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

**Bonus Sweepstakes Entries:** During the Promotion Period, there are five (5) ways to earn bonus Sweepstakes entries as outlined below:

**i. Twitter Share:** After you enter the Promotion, you will be invited to share the Promotion on Twitter by clicking on the link to share a prepopulated message on Twitter. You will earn one (1) bonus entry into the applicable Daily Entry Period drawing. **Limit:** one (1) bonus Sweepstakes entry per day during the Promotion Period.

**ii. Tell A Friend Program:** After you enter the Promotion, you will be invited to submit the names and email addresses of up to three (3) friends who must be eligible to enter the Promotion. Each person that you refer will receive an email notifying him or her about the Promotion. You may only refer persons with whom you have an existing relationship. For each referral of up to three (3) friends with valid email addresses, you will be given one (1) additional Sweepstakes entry into the applicable Daily Entry Period drawing, up to a total of three (3) additional entries per day during the Promotion Period.

**iii. Facebook Share:** After you enter the Promotion, you will be invited to share the Promotion on your Facebook wall. The wall post will contain a unique link to the Promotion. You will receive one (1) bonus entry into the applicable Daily Entry Period drawing for each friend that registers for the Promotion through the unique link you posted. **Limit:** one (1) bonus Sweepstakes entry per day during the Promotion Period.

**iv. Video:** After you enter the Promotion, you will be invited to watch a short video. You will earn one (1) bonus entry into the applicable Daily Entry Period drawing. **Limit:** one (1) bonus Sweepstakes entry during the Promotion Period.

**v. Follow O'Reilly on Instagram:** After you enter the Promotion, you will be invited to click on the Instagram Follow button to "FOLLOW" O'Reilly on Instagram. You will earn one (1) bonus entry into the applicable Daily Entry Period drawing. **Limit:** one (1) bonus Sweepstakes entry during the Promotion Period.

**5. Sweepstakes/Instant Win Game:** Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. **Sweepstakes:** Administrator will randomly select the potential Daily Entry Period winners from all eligible entries received during the applicable Daily Entry Period within seven (7) business days following the conclusion of the applicable Daily Entry Period. Non-winning Daily Entry Period entries will carry over into subsequent Daily Entry Period drawings. **Instant Win Game:** Seventeen thousand five hundred (17,500) random, computer-generated winning times, one for each prize listed below, will be generated during the Promotion Period. For the First prize there will be five hundred (500)

random, computer-generated winning times per Daily Entry Period. If you are the first player to play the Instant Win Game at or after one of the randomly-generated times, you will be a potential instant winner of the prize indicated.

**6. ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR OR ADMINISTRATOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE PROMOTION. **7. Verification of Potential Winners:** Receiving a prize is contingent upon compliance with these Official Rules. The potential Sweepstakes winners will be notified by email or phone. If a potential winner of any prize cannot be contacted, or fails to provide any requested information within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits the prize. In the event that a potential winner of the Grand Prize is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. There will be three (3) alternate drawings after which the prize will remain unawarded. Unclaimed First Prizes will not be awarded. Prizes will be fulfilled approximately 8-10 weeks after the conclusion of the Promotion.

#### **8. Prizes:**

**Sweepstakes Prizes:** THIRTY-FIVE (35) GRAND PRIZES (one (1) awarded per Daily Entry Period): A \$100 O'Reilly Auto Parts electronic gift card Terms and conditions of gift codes apply. Approximate Retail Value ("ARV"): \$100. Odds of winning a Sweepstakes Prize depend on the number of eligible entries received during the applicable Daily Entry Period. Limit: One (1) Sweepstakes prize per person.

**Instant Win Game Prizes:** SEVENTEEN THOUSAND FIVE HUNDRED (17,500) FIRST PRIZES: A \$10 O'Reilly Auto Parts electronic gift card. Terms and conditions of gift codes apply. ARV: \$10. Odds of winning an Instant Win Game prize depend on the number of Instant Win prizes available divided by the number of eligible Instant Win Game plays. Limit: One (1) Instant Win Game prize per person, per day.

For All Prizes: No cash equivalent and all prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. **9. Release:** By receipt of any prize, winner agrees to release and hold harmless Sponsor, HelloWorld, Inc., and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Promotion or receipt or use or misuse of any prize.

**10. Publicity:** Except where prohibited, participation in the Promotion constitutes winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further

**11. General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Sweepstakes or Instant Win Game, as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to award the prizes at random from among the eligible entries or plays received up to the time of the impairment. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or Instant Win Game or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes or the Instant Win Game may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

**12. Limitations of Liability:** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any prize. If for any reason an entrant's entry or play is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another Sweepstakes entry or Instant Win Game play, if possible. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

**13. Disputes:** Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of Michigan, without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.
